# **1 MEDICAL EXPERT**

# 1.1 Knowledge of Anatomy and Physiology Objectives:

- 1 Demonstrate extensive knowledge of:
  - a) Maternal physiological changes during pregnancy
  - b) Fetal physiology and development
  - c) Antepartum assessment of mother and fetus
  - d) Effect of medical, surgical, social and environmental conditions on pregnancy
- 2 Demonstrate extensive knowledge of the pathophysiology, prevention, investigation, diagnosis and management of common obstetric complications of pregnancy including:

a)	Second trimester pregnancy loss	g) Fetal growth restriction

- 3 Demonstrate knowledge of the presentation, investigation, diagnosis and management of common maternal medical conditions and their subsequent complications in pregnancy, including hypertension, systemic lupus erythematosus (SLE), diabetes, thrombophilias, cardiac disease, morbid obesity, epilepsy, and maternal infections
- 4 Demonstrate working knowledge of genetic screening procedures (First Trimester Screen, Integrated Prenatal Screening), Non-Invasive Prenatal Testing (NIPT), genetic diagnostic procedures, and genetic counseling.
- 5 Demonstrate ability to initiate discussion pertaining to care at the threshold of viability.

# 1.2 Data Gathering Objectives

- 1 Obtain a relevant history and perform a physical exam on a pregnant woman seen for a medical, surgical or obstetrical complication of pregnancy.
- 2 Perform and interpret a fetal assessment test (NST/ BPP).
- 3 Interpret fetal Doppler studies.

## **1.3 Clinical Reasoning, Management and Judgment/Diagnostic and Therapeutic Planning** Objectives:

- 1 Synthesize information gathered in the history and physical exam and plan further relevant investigations.
- 2 Use information gathered in history/physical exam, other investigations to plan appropriate management of the patient.

## 1.4 Procedural skills Objectives:

- 1 Perform appropriate therapeutic maneuvers skillfully; such as vaginal delivery, operative delivery (vaginal operative or cesarean section), and twin deliveries.
- 2 Individualize surgical approach to high-risk obstetrical complications, such as placenta previa, placenta accreta, classical Cesarean sections, and cerclage.

# **2 COMMUNICATOR**

## 2.1 Physician/Patient Relationship Objectives:

- 1 Establish a therapeutic relationship with patients/families.
- 2 Listen effectively, discuss appropriate information with patients/families.
- 3 Teach patients/families, as appropriate.

## 2.2 Verbal / Written Communication Skills Objectives:

- 1 Convey bad news with empathy to patients and families.
- 2 Complete health records in an accurate and timely manner.

# **3 COLLABORATOR**

## 3.1 Team Relations Objectives:

- 1 Demonstrate appropriate communication skills when interacting with all members of the multidisciplinary healthcare team and administrative staff.
- 2 Work effectively with other members of the healthcare team to promote a positive team relationship in caring for the patient.
- 3 Collaborate on complex patient care plans with colleagues from other disciplines (e.g., Pediatrics, Medicine, Anesthesia).
- 4 Communicate proper care plan to family physician on discharge

# 4.1 Time Management Objectives:

#### 6.1 Self-Directed Learning Objectives:

- 1 Demonstrate a critical approach to the literature regarding investigation, therapeutics and healthcare delivery with respect to maternal fetal medicine.
