



## **Maternal Fetal Medicine Specialist** **Women's and Children's Health Program, Trillium Health Partners**

Trillium Health Partners' Women's and Women's Health Program is seeking a **Maternal Fetal Medicine (MFM) Specialist** to join our team. Join us in shaping the future of healthcare by being an integral part of building towards Ontario's first Women's and Children's Hospital, which will have an impact on generational health in one of the nation's most multicultural regions.

**THP Women's & Children's Program:** Trillium Health Partners (THP) serves over one million residents in Mississauga, Peel Region, and West Toronto. By autumn 2025, Women's and Children's health services will consolidate at Credit Valley Hospital (CVH), supporting up to 9000 births annually and a 48-bed Level 2C NICU. This consolidation will support a one patient and provider experience within a comprehensive system of care in advance of the new hospital opening in the coming years.

At THP, we are building Ontario's first Women's and Children's Hospital—the Shah Family Hospital for Women and Children. This 200,000-square-foot facility will span two floors within the new Peter Gilgan Mississauga Hospital and will be purpose-built for families to provide a range of specialized services and integrated care. Key features will include 31 birthing suites, 53 postpartum beds, 56 NICU beds, and 36 pediatric beds. Every aspect of care will be designed to prioritize the patient and family experience while ensuring the highest quality of care. The new hospital will also focus on teaching, research, and innovation to promote the well-being of women, children, and equity-deserving groups. THP fosters innovation, partnerships, and research through the Institute for Better Health (IBH) and is the primary teaching hospital for the University of Toronto's Mississauga Academy of Medicine.

**MFM at THP:** The MFM program is expanding to include a team of three MFM specialists. The clinic currently operates out of a dedicated on-site clinic at the Credit Valley Hospital, offering comprehensive care for high-risk pregnancies in our diverse community. The clinic runs full-time, Monday to Friday, and is supported by a multidisciplinary team, including Maternal-Fetal Medicine Specialists, Nurse Practitioners, Registered Nurses, Social Workers, and specialists such as Geneticists, Endocrinologists, Nephrologists, and Pediatricians/Neonatologists. Services such as fetal echocardiography and amniocentesis are provided on-site, ensuring timely diagnosis and care planning. The MFM Specialist will work closely with the Diagnostic Imaging team, overseeing obstetric ultrasounds conducted within the fetal assessment unit.

**MFM Role:** The role involves providing expert consultation to healthcare providers across the region, focusing on all aspects of high-risk pregnancy care. The MFM Specialist will manage complex pregnancies involving maternal medical conditions, fetal anomalies, and complications such as

preeclampsia, intrauterine growth restriction, and antepartum hemorrhage. Responsibilities include participation in the high-risk clinic, high-risk antenatal inpatient care, ultrasound reporting, amniocentesis, prenatal diagnosis, elective cesarean delivery blocks, and labor & delivery on-call services. The role also involves contributing to research and education, with interests in areas such as health equity, quality improvement, and patient education.

**Qualifications:** The ideal candidate must be proficient in English, hold a Doctor of Medicine (MD), and be certified or eligible for certification by the Royal College of Physicians and Surgeons of Canada. Candidates must hold or be eligible for licensure with the College of Physicians and Surgeons of Ontario (CPSO). A Royal College-approved fellowship in Maternal-Fetal Medicine is mandatory. Applicants must also be eligible for a full-time clinical academic appointment at the University of Toronto, at the rank of Assistant, Associate, or Full Professor. Applications from candidates at higher academic ranks are welcomed. Clinical Investigator Funding is possible for qualified candidates. Start date is flexible.
